



# EXCHANGE RATE TUITION APPLICATION FORM

The heart of The Bridge School is our committed families who desire active roles in our classrooms and school to enrich and support our programs. However, we understand that some families have responsibilities that don't allow them to fulfill the standard number of work hours. In recognition of this, we offer a limited number of Exchange Tuition Rates to accommodate families with considerable time constraints.

Exchange Tuition Rates allow families to pay 25% higher tuition in exchange for reduced work hour requirements. For the 2017-2018 school year, families with Exchange Tuition Rates will be required to work a minimum of 94 hours per year for dual parent families and 47 hours per year for single parent families. Exchange rate tuitional waives the need to hold a Classroom Support Position or complete cleaning shifts, though you will still be placed on a School Support Team.

Exchange Tuition Rates are awarded annually and apply to all enrolled children within a family.
